RE: NORTHERN PLAINS INTERTRIBAL COURT OF APPEALS

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe and the Omaha Indian Reservation; to regulate all manner of trade and commerce; to regulate all manner of criminal and non-criminal conduct, subject to any limitation of federal law; and

WHEREAS: the Northern Plains Intertribal Court of Appeals request the authority to contract, administer and operate under Public Law 93-638, as amended, the appellate Court Service Program for the Omaha Tribe of Nebraska and other membership tribes for the Fiscal Year 2024-2026

WHEREAS: Article X, Section 1 of the Constitution of the Omaha Tribe of Nebraska provides The Omaha Tribal Courts shall consist of... an appellate court. The Tribal Council shall appoint ... Appellate Judges ... as the Council deems necessary.

WHEREAS: The Omaha Tribe of Nebraska is a member of the Northern Plains Intertribal Court of Appeals(NPICA), and has delegated appellate court authority to the NPICA previously by resolution.

NOW THEREFORE, BE IT RESOLVED THAT: the Omaha Tribal Council hereby authorizes the Northern Plains Intertribal Court of Appeals to contract, administer and operate the Appellate Court Service Program for the **Fiscal Years 2024-2026**.

NOW THEREFOR, BE IT FURTHER RESOLVED THAT: that the President or other authorized representative of the Northern Plains Intertribal Court of Appeals shall be authorized to negotiate and/or sign on behalf of the Intertribal Court of Appeals.
