RE: Government to Government Compacting with Jim Pillen Governor of Nebraska concerning motor fuel tax, class III gaming, and Tobacco products.

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (a) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to negotiate with the ...State ... governments on behalf of the Tribe; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Article IV, Section 1 (m) To adopt resolutions regulating the procedures of the Tribal Council itself and of other Tribal agencies and Tribal offices; and

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council finds it is in the best interest of the Omaha Tribe of Nebraska to deliver letter's to Jim Pillen, Governor of the State of Nebraska, and any further representative of the State of Nebraska that become necessary regarding ongoing inappropriate taxation of the Tribe.
