## OMAHA TRIBE OF NEBRASKA

**RE:** PL93-638 ICWA-BUDGET MOD & SOW MOD – A22AV00575

**WHEREAS:** The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

**WHEREAS:** Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

**WHEREAS:** The Omaha Tribal Council elects to modify the Statement of Work and Budget to allow for a budget mod to move salary & fringe benefit and all other budgeted funds to the Contractual line item GL6002. There is also a change to the Statement of Work to allow for contractual attorney fees. The ICWA program is also requesting approval to pay up to 3 months of contractual attorney fees currently incurred. It is vital to continue protection for off-reservation children through proper ICWA representation.

**NOW THEREFORE, BE IT RESOLVED THAT:** The Omaha Tribal Council adopts the attached modified Statement of Work and Budget and approves the submittal of ICWA Program modification to the Bureau of Indian Affairs.
