WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the

governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: pursuant to Article IV, Sec. 1 (g) of the constitution of the Omaha Tribe of Nebraska the

governing body of the Omaha Tribe shall also be known as Tribal council; and

WHEREAS: the Omaha Tribe has four (4) applicants that meet the requirement of \(^1/4\) (25\%)

Omaha Blood.

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general

welfare of the Omaha Tribe; and,

WHEREAS: the Supplemental Roll 148 will now start with the Tribal Roll Number 9977, and will end

with Tribal Roll Number 9980.
