The Omaha Tribe of Nebraska ARPA Project - Omaha Lodges Roof Repair

RFP approval

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant

to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the

governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: pursuant to Article IV, Section 1 (a) of the constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to negotiate with Federal, State, and local governments on behalf of the Tribe, and to advise and consult with the representatives of the Department of the Interior on all activities of the Department that may affect the

Omaha Tribe; and

WHEREAS: pursuant to Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy

and general welfare of the Omaha Tribe; and

WHEREAS: in response to the COVID-19 public health emergency, the federal government enacted the American Rescue Plan Act ("ARPA"), Pub. L. 117-2 (Mar. 11, 2021), which provided funding for the prevention, recovery and mitigation of COVID-19 and its effects; and

WHEREAS: the Omaha Tribe of Nebraska established several projects designed to provide a safe and healthy home environment for its citizens, including the Omaha Lodges Roof Repair Project; and

WHEREAS: the Project is anticipated to cost approximately \$191,811, and such amount falls under the "Procurement By Competitive Proposals" section of the Omaha Tribe's Procurement Policy and Procedures for items costing > \$150,001 to \$250,000; and

WHEREAS: the same section of the Procurement Policy and Procedures requires a Request for Proposal (RFP) and Tribal Council minutes and resolution; and

NOW THEREFORE, BE IT RESOLVED THAT: the Omaha Tribal Council hereby approves the RFP for the Omaha Lodges Roof Repair.
