**RE:** Tribal Council grants authorization to the BBC board to authorize charitable donation to tribally affiliated programs.

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Article IV, Section 1 (f) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to manage all economic affairs and enterprises of the Tribe; and

WHEREAS: The Blackbird Bend Casino is an enterprise of The Omaha Tribe of Nebraska.

WHEREAS: It is in the best interest of the Omaha Tribe for the BBC Board to be granted authority to approve charitable donations in an amount equal to or less than \$2,500.00 to tribally affiliated programs only without further authorization from the Omaha Tribal Council.

**NOW THEREFORE, BE IT RESOLVED THAT:** The Omaha Tribal Council grants authority to the Blackbird Bend Casino Board to approve charitable donations in an amount equal to or less than \$2,500.00 to tribally affiliated programs only without further authorization from the Omaha Tribal Council.
