RESOLUTION NO. 24-114 OF THE OMAHA TRIBE OF NEBRASKA

RE: Affirming Ownership of Tribal Buildings on Tribal Land: Lil' Indian Daycare building.

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian Tribe organized pursuant to the Indian Reorganization Act of June 18, 1934 (25 U.S.C. 476 as amended); and,

WHEREAS: Article IV, Section 1 (c) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to approve or veto any sale, disposition, lease, or encumbrance of tribal lands, interests in lands or other tribal assets, which may be authorized or executed by the Secretary of the Interior, the Commissioner of Indian Affairs, or any other qualified official or agency of government, providing that no reservation lands shall ever be leased for a period exceeding ten (10) years, sold, or encumbered, except for governmental purposes; and,

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and,

WHEREAS: Article IV, Section 1 (p) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to protect and preserve the property, wildlife, and natural resources of the Tribe; and,

WHEREAS: The Omaha Tribe of Nebraska is the sole owner of the Lil' Indian Daycare building which is located on Omaha Tribe of Nebraska Trust land in Macy, Nebraska.

WHEREAS: The building is located on trust land as follows:

Lil' Indian Daycare: 545 Indian Hills Drive, Macy, NE 68039
Located between Omaha Tribal Police & Adult Detention, Building 2 Indian Hills Drive, and UMOnHOn Alcohol Program, 575 Indian Hills Drive, Village of Macy, Thurston County, Nebraska.

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council hereby states and confirms ownership of the Lil' Indian Daycare building, for the purpose and use as a healthcare facility, to the Carl T Curtis Health Education Center (CTCHEC).
