WHEREAS: the Omaha Tribe of Nebraska is a Federally recognized Indian Tribe organized under a

constitution and bylaws pursuant to Section 16 of the Indian Reorganization Act of 1934,

(25 U.S.C. § 5123); and,

WHEREAS: pursuant to Article III, Section 1 of the Constitution of the Omaha Tribe of Nebraska, the

governing body of the Omaha Tribe shall be known as the Tribal Council; and,

WHEREAS: pursuant to Article IV, Section 1 (f) of the Constitution of the Omaha Tribe of Nebraska,

the Omaha Tribal Council has the authority to manage all economic affairs and enterprises

of the Tribe; and,

WHEREAS: pursuant to Article IV, Section 1 (p) of the Constitution of the Omaha Tribe of Nebraska,

the Omaha Tribal Council has the responsibility to protect and preserve the property.

WHEREAS: The Tribal Council met on October 26th and October 28th of 2021.

WHEREAS: The Secretary, Gwen Porter, of the Council was at the meeting but was not present for the

entire Council meeting. Cheyenne Robinson Vice-Chairman was acting Secretary for this

meeting in Gwen Porter's absence.

WHEREAS: The recording Secretary was Raylene Lasley.

WHEREAS: Due to a change-over in staff the October 26th and 28th 2021 minutes were not immediately
