WHEREAS, the above mentioned member is requesting that their name be stricken from the Enrollment Roll of the Omaha Tribe of Nebraska, and

WHEREAS, the Omaha Tribe of Nebraska Enrollment Committee has reviewed and approved relinquishment, forwarding unto the Omaha Tribal Council for final approval.

WHEREAS, records from the Omaha Tribal Enrollment Office will show that the above individual relinquishment was made in accordance with the Policy and Procedures.

NOW, THEREFORE BE IT RESOLVED THAT, the Omaha Tribal Council hereby accepts and approves the voluntary relinquishment of the individual listed above from the Omaha Tribe of Nebraska.

BE IT FURTHER RESOLVED THAT, the above-mentioned member with the passage of this Resolution will forfeit any and all claims against the Omaha Tribe now or in the future.




