## RESOLUTION NO. 24-<u>126</u> OF THE

## OMAHA TRIBE OF NEBRASKA

RE: Authorization to Drawdown \$1,300,000 from the Omaha Tribe Trust Account for Deposit into the Land Lease Revenue Account

- WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and
- WHEREAS: Article IV, Section 1 (g) of the Constitution of the Omaha Tribe of Nebraska, the Tribal Council has the authority to appropriate for public purposes to the Omaha Tribe of Nebraska available funds within the exclusive control of the tribe and any other available Tribal funds; and
- **WHEREAS:** The Omaha Tribe has the authority to draw down funds held in trust for the Office of Special Trustees; and
- WHEREAS: In order to provide funds for the operation of the Tribal Government, from time-to-time, the Omaha Tribe of Nebraska makes routine requests for a drawdown of funds held in trust for the Tribe by the Office of Trust Funds Management in the office of the Special Trustee for American Indians of the Department of Interior; and
- **WHEREAS:** The Omaha Tribe of Nebraska requires a routine drawdown of funds at this time to provide funds for the continuing operation of the Tribal and for services in support of the general health and welfare of the Omaha Tribal members; and
- WHEREAS: The Omaha Tribal Council enacts this resolution to request a wire transfer of funds held in trust for the Omaha Tribe of Nebraska by the Office of the Special Trustee for American Indians to the Omaha Tribe of Nebraska's Land Lease Revenue Account, in the amount of One Million three Hundred Thousand Dollars (\$1,300,000.00).

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council hereby requests an immediate drawdown of funds in the amount of One Million Three Hundred Thousand Dollars (\$1,300,000.00) from the following account held in in trust by the Office of Trust Funds management for the benefit of the Omaha Tribe of Nebraska: P17262709.

**BE IT FURTHER RESOLVED THAT:** the Omaha Tribal Council of the Omaha Tribe of Nebraska request that such funds be transferred to the Omaha Tribe of Nebraska's Land Lease Revenue account #210-544 at Charter West Bank, Walthill NE 68067, Routing Number 104901665.
