RESOLUTION NO. 24-128

RE: Additional Funding For Omaha Tribe Summer Youth Programs

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Omaha Tribal Council, pursuant to Article IV, (I)j, has the Responsibility to safeguard, promote and enforce the peace, economy, safety, law and order, and general welfare of the Tribe and the Omaha Reservation; and

WHEREAS: The Omaha Tribe of Nebraska maintains a Summer Youth Employment Program to ensure that youth gain valuable workforce experience and have a safe, productive way to spend their time. This program provides subsidized wages for youth who work at selected tribal departments during the summer, and often include job readiness training and other supports for youth who participate, and

WHEREAS: The Summer Youth Employment Program Manager has indicated that there is limited funding under the Workforce Investment Opportunities Act to support the anticipated three groups of twenty-five (25) youths for short one-week to two-week work assignment, and asks for assignment of additional resources, and

WHEREAS: The Tribal Council supports development of tribal youth, and believes that it's in the best interest of the Tribe to provide additional funding for the Summer Youth Employment Program, and that the TERO Department and Tax Department has each

identified \$40,000 and \$30,000 respectively that could be re-programmed to benefit the Summer Youth Employment Programs;

NOW THEREFORE, BE IT FURTHER RESOLVED THAT: the Omaha Tribal Council does authorize its Chief Financial Officer to reallocation \$40,000 from the TERO Department and checking account at Charter West, and \$30,000 from the Tax Department and its checking account at Charter West; and to deposit these funds into the Workforce Improvement Opportunities Act account, and

BE IT FURTHER RESOLVED THAT: the Omaha Tribal Council directs its Summer Youth Employment Program Manager to revise the annual budget upward by an additional \$70,000 as needed.


