**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

**WHEREAS:** the Omaha Tribe has established the Head Start and Early Head Start Program to provide quality comprehensive child development services that are family focused. The services include education, health, nutrition, and mental health.

**WHEREAS:** the Omaha Tribe would like to continue these services so the health, welfare, and safety of the tribal members in protected and honored.

**NOW THEREFORE, BE IT RESOLVED THAT:** the Omaha Tribal Council of the Omaha Tribe of Nebraska approves the request to submit an application for non-competing continuation of funding for the period of January 1, 2025 to December 31, 2025 in the amount of \$3,200,174.
