## OMAHA TRIBE OF NEBRASKA

RE:

Approving the American Rescue Plan Act's Interagency Agreement Policy and Procedures

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: This policy establishes a standardized procedure for creating, approving, managing, and terminating interagency agreements in compliance with the OMB Uniform Guidance (2 CFR Part 200), the 2024 State and Local Fiscal Recovery Funds Obligation Interim Final Rule, the State and Local Fiscal Recovery Fund Final Rule, and relevant FAQs; and

WHEREAS: This policy applies to all interagency agreements entered into between the Omaha Tribe of Nebraska's Tribal Government Units for purposes of obligating American Rescue Plan Act State and Local Fiscal Recovery Funds (ARPA-SLFRF); and

**NOW THEREFORE, BE IT RESOLVED THAT:** the Omaha TRIBAL COUNCIL hereby approves the "ARPA-Interagency Agreement Policy and Procedures."
