# RESOLUTION NO. 24-149 OMAHA TRIBE OF NEBRASKA

### Authorizing Dividend / Distribution To Support Ongoing Tribal Activities - \$550,000

- WHEREAS: The Omaha Tribe of Nebraska is federally recognized Indian tribe organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- **WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and
- **WHEREAS:** pursuant to Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and
- **WHEREAS:** The Tribal Council of the Omaha Tribe of Nebraska believes that it is in the best interest of the Tribe, and of its members and employees, to provide ongoing financial support to programs which collectively address strategic priorities and provide substantiative benefits to tribal members, and
- **WHEREAS**, the Tribal Council has identified programs which meet these strategic objectives, and would like to expand and financial support these programs by providing \$550,000 of additional operating capital,
- **NOW THEREFORE BE IT RESOLVED THAT:** The Tribal Council, through its representation on the Blackbird Bend Corp., the Omaha Tribal Tax Commission, the Omaha Tribal Employment Rights Office, directs the following special dividend / distributions and reallocations, as follows:

Blackbird Bend Corporation - \$150,000.00 Omaha Tribal Tax Commission - \$100,000.00 Omaha Tribal Employment Rights Office - \$150,000.00 Other Internal Tribal Resources - \$150,000.00 BE IT FURTHER RESOLVED: That time being of the essence, these special dividends / distributions and re-allocations shall take place as of August 31, 2024, or as soon as administratively practical, and

BE IT FINALLY RESOLVED THAT: The Tribal Council hereby authorizes Chairman Jason Sheridan and Treasurer Alan Harlan execute any and all documents necessary to affect this resolution.
