RE: Veterans Group use of the Spiritual Center.

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Article IV, Section 1 (c) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to approve or veto any sale, disposition, lease, or encumbrances of Tribal lands, interests in lands or other Tribal

WHEREAS: Article IV, Section 1 (m) To adopt resolutions regulating the procedures of the Tribal Council itself and of other Tribal agencies and Tribal offices; and

WHEREAS: The Omaha Tribe of Nebraska placed a building on Tribal Trust Land at Section: 25 Town: 25 Rng: 9E, Block 3 Lot: 16,17,18 Addition : Chase

WHEREAS: This building shall be henceforth known as the Umoⁿ hoⁿ Veterans Society Building.

WHEREAS: The building and its upkeep, maintenance, and utilities shall henceforward be the responsibility of the Omaha Tribe of Nebraska.

WHEREAS: The Omaha Tribe of Nebraska Tribal Council will create appropriate policies governing future use of the Umoⁿ hoⁿ Veterans Society Building by Omaha Tribal programs and community members.

WHEREAS: The Omaha Tribe of Nebraska supports our Omaha Tribal Member Veterans; To that end the Umoⁿ hoⁿ Veterans Society and are in need of use of the Umoⁿ hoⁿ Veterans Society Building for meetings and events at no cost. The Veterans Group, shall have a permanent office located in the Veterans Center.

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council finds it is in the best interest of the Omaha Tribe of Nebraska to name the building located at Section: 25 Town: 25 Rng: 9E, Block 3 Lot: 16,17,18 Addition : Chase known as Umoⁿ hoⁿ Veterans Society Building, to upkeep the building, to create policies governing other future use, to support the Omaha Tribal Veterans by allowing use of this facility for meeting and events at no cost, and to supply permanent office space to the veteran’s group.
