- WHEREAS, pursuant to Article III, Sec. 1 of the constitution of the Omaha Tribe of Nebraska, the Governing body of the Omaha Tribal shall be known as Tribal Council: and
- WHEREAS, Article IV, Sec.1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general Welfare of the Omaha Tribe: and
- WHEREAS, the individual listed above wishes to relinquish enrollment with the Omaha Tribe of Nebraska and
- WHEREAS, the above mentioned member is requesting that their name be stricken from the Enrollment Roll of the Omaha Tribe of Nebraska.
- NOW, THEREFORE BE IT RESOLVED THAT, the Omaha Tribal Council hereby authorizes and declares and hereby accepts the voluntary relinquishment of the individual listed above from the Omaha Tribe of Nebraska.
- BE IT FURTHER RESOLVED THAT, the Omaha Tribe Council hereby authorizes and declares that the above-mentioned member with the passage of this Resolution will forfeit any and all claims against the Omaha Tribe now or in the future
