RE: *PL 93-638 Contracting Request Fiscal 2025 for Law Enforcement and Detention*

WHEREAS: The Omaha Tribe of Nebraska is federally recognized Indian tribe of organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: pursuant to Article IV, Sec. 1 (g) of the constitution of the Omaha Tribe of Nebraska the governing body of the Omaha Tribe shall also be known as Tribal council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and,

NOW THEREFORE, BE IT RESOLVED THAT: the Omaha Tribal Council adopts the Model Section 108 and Model AFA for the Law Enforcement and for the Detention Programs and approved the P.L. 93-638 Contract Request for FY 2025 for the following programs:

A24AV00121 Law Enforcement – Direct Cost \$1,787,388


A24AV00120 Detention – Direct Cost \$903,961
