## RESOLUTION NO. 25-18 OF THE OMAHA TRIBE OF NEBRASKA

### *RE: Authorization of Tribal Officials of the Omaha Tribe of Nebraska*

**WHEREAS:** The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

**WHEREAS:** Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

**WHEREAS:** Article IV, Section I (c) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to approve or veto any sale, disposition, lease, or encumbrance of tribal lands, interests in lands or other tribal assets, which may be authorized or executed by the Secretary of the Interior, the Commissioner of Indian Affairs, or any other qualified official or agency of government, providing that no reservation lands shall ever be leased for a period exceeding ten (10) years, sold, or encumbered, except for governmental purposes; and,

**WHEREAS:** Article IV, (p) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to protect and preserve the property wildlife and natural resources of the Tribe; and,

**WHEREAS:** The following officials or tribal employees are authorized by Tribal resolution to conduct business with the Office of the Special Trustee for American Indians and to receive trust information from the U.S. Department of the Interior.

**WHEREAS:** The following officials are authorized to initiate disbursements to the Omaha Tribe, and to receive information about the tribal IIM or investment accounts.

**WHEREAS:** This authorization includes authorization to sign documents from the Office of the Special Trustee for American Indians on the behalf of the Omaha Tribe.


**NOW THEREFORE, BE IT RESOLVED THAT:** The Omaha Tribal Council hereby authorizes the following officials to exercise the authority described above in behalf of the Omaha Tribe; Jason Sheridan - Chairman, Vice-Chairman - Leander Merrick Treasure - Alan Harlan, Secretary - Cheyenne Robinson, Members - Jerome Hamilton Galen Aldrich Sr, Dustin Lovejoy.
