RE: *Application for F24AS00241_Fiscal Year 2025_Tribal Wildlife Grant for \$199,965.*

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Omaha Tribal Council, pursuant to Article IV, (I)j, has the Responsibility to safeguard, promote and enforce the peace, economy, safety, law and order, and general welfare of the Tribe and the Omaha Reservation; and

WHEREAS: the Omaha Tribe operates a number of programs in facilities located throughout the Tribe's service area; and

WHEREAS: the Omaha Tribe desires that public health and safety standards be met for each of the Tribe's facilities; and

WHEREAS: the Omaha Tribe finds that wildlife and parks needs an additional conservation officer,

NOW THEREFORE, BE IT RESOLVED THAT: The Omaha Tribal Council of the Omaha Tribe of Nebraska authorizes the application for the Tribal Wildlife Grant in the amount of \$199,965.
