RESOLUTION NO. 25-45

OF THE

OMAHA TRIBE OF NEBRASKA

RE: MANDATING ALL PROGRAMS AND DEPARTMENTS OF THE OMAHA TRIBE OF NEBRASKA TO UTILIZE PAHE MART AND C-STORE FOR FUEL PURCHASES IN SUPPORT OF TRIBAL ECONOMIC DEVELOPMENT AND SOVEREIGNTY.

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: Article IV, Section 1 (m) To adopt resolutions regulating the procedures of the Tribal Council itself and of other Tribal agencies and Tribal offices; and

WHEREAS, the Tribe owns and operates **Pahe Mart** and **C-Store**, which provide fuel, convenience store services, and economic benefits to the Tribe; and

WHEREAS, the revenues generated by Pahe Mart and C-Store contribute directly to the Tribe's economic development, self-sufficiency, and support essential programs and services for tribal members; and

WHEREAS, mandating the use of tribal-owned gas stations will strengthen the Tribe's economic base, increase revenues for reinvestment, and uphold the principles of tribal sovereignty and self-determination; and

WHEREAS, it is in the best interest of the Omaha Tribe of Nebraska to ensure all tribal programs and departments prioritize supporting tribal enterprises;

NOW, THEREFORE, BE IT RESOLVED that the Omaha Tribal Council hereby mandates that all programs, departments, and entities under the Omaha Tribe of Nebraska utilize **Pahe Mart** and **C-Store** for all fuel purchases, unless such fuel purchases are unavailable, or it is logistically impractical.

BE IT FURTHER RESOLVED that the Tribal Administration and Finance Office shall monitor compliance with this resolution and provide necessary support to ensure efficient implementation, including establishing accounts or procedures with Pahe Mart and C-Store.


BE IT FINALLY RESOLVED that this resolution shall take effect immediately upon approval and remain in full force unless otherwise amended or rescinded by the Tribal Council.

CERTIFICATION
