## RESOLUTION NO. 25-64

### OF THE

### OMAHA TRIBE OF NEBRASKA

**RE:** Authorizing the Broadcasting of Regularly Called and Emergency Meetings of the Omaha Tribal Council

**WHEREAS:** The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

**WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

**WHEREAS:** Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

**WHEREAS,** the Omaha Tribal Constitution provides for transparency, accountability, and participation in tribal governance as core principles; and

**WHEREAS,** the Omaha Tribal Council recognizes the need to ensure accessibility to its proceedings for tribal members who may not be able to attend meetings in person due to geographic, health, or other constraints; and

**WHEREAS,** broadcasting meetings via YouTube will allow for increased transparency, participation, and communication with tribal members while maintaining the integrity of the Council's proceedings; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Omaha Tribal Council hereby authorizes the broadcasting of all regularly called meetings and emergency meetings via a secure YouTube channel, accessible to enrolled tribal members; and

**BE IT FURTHER RESOLVED,** that the broadcasts shall comply with applicable laws and policies of the Omaha Tribe to protect the confidentiality of sensitive discussions, and that executive sessions or confidential matters shall not be broadcast; and

**BE IT FURTHER RESOLVED,** that the Omaha Tribal Council directs its IT Department to establish the necessary technology, security measures, and protocols for broadcasting meetings in accordance with this resolution; and


**BE IT FINALLY RESOLVED**, that this resolution shall take effect immediately upon its approval by the Omaha Tribal Council.

**CERTIFICATION**
