RESOLUTION NO. 25-74 OF THE OMAHA TRIBE OF NEBRASKA

RE: Omaha Tribe Signature Authority for all FSA/NCRS matters

- WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and
- **WHEREAS:** pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and
- WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and
- WHEREAS: Article IV, Section 1 (c) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to approve or veto any sale, disposition, lease or encumbrance of tribal land, interest in land or other trial assets, which may be authorized or executed by the Secretary of the Interior, the Commissioner on Indian Affairs, or any other qualified official or agency of government, providing that no reservation lands shall be leased for a period exceeding the (10) years, sold, or encumbered, except for governmental purposed; and,
- **WHEREAS**: The Omaha Tribe Realty requires signature authority to complete FSA/NCRS lease agreements and all other relevant activities of the Realty Department on behalf of the Omaha Tribe of Nebraska.
- **NOW THEREFORE, BE IT RESOLVED THAT:** The Omaha Tribal Council hereby approves and authorizes signature authority with the Thurston County FSA/NCRS office(s) on all agreements and related activities in the best interest of the Omaha Tribe.
