RESOLUTION NO. 25-84

OF THE

OMAHA TRIBE OF NEBRASKA

RE: Authorization of Annual TERO Allocation to Higher Education and Senior Center

WHEREAS: The Omaha Tribe of Nebraska is a federally recognized Indian tribe, organized under a constitution and bylaws approved by the Secretary of Interior on April 30, 1936, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934; and

WHEREAS: pursuant to Article III, Sec.1 of the constitution of the Omaha Tribe of Nebraska, the governing body of the Omaha Tribe shall also be known as Tribal Council; and

WHEREAS: Article IV, Section 1 (j) of the Constitution of the Omaha Tribe of Nebraska provides the Omaha Tribal Council with the power to safeguard and promote the economy and general welfare of the Omaha Tribe; and

WHEREAS: The Tribal Employment Rights Office (TERO) ensures that the Tribe benefits from employment and business opportunities generated within its jurisdiction by collecting a 6% fee on applicable projects; and

WHEREAS: The Council recognizes the critical role of the Higher Education Program in supporting tribal members pursuing degrees and certifications, thereby strengthening the Tribe's workforce and economic sustainability; and

WHEREAS: The Council acknowledges the invaluable contributions of the Omaha Tribe's elders and the necessity of providing continued support for the Senior Center, which offers essential services, care, and cultural engagement opportunities for the elders, and

WHEREAS: The Council finds that it in the best interest of the Tribe to allocate 15% of the annual TERO revenue – 5% to the Higher Education Program and 10% to the Senior Center – to ensure ongoing investment in education and elder care;

NOW THEREFORE BE IT RESOLVED: The Omaha Tribal Council hereby approves the annual allocation of 15% of total TERO revenue, with 5% designated for the Higher Education Program and 10% designated for the Senior Center to support tribal students and elders. The Tribal Employment Rights Office (TERO) is directed to implement this allocation and ensure the funds are properly distributed annually.

CERTIFICATION

This is to certify that the foregoing resolution was considered at a duly called meeting of the Omaha Tribal Council on the 6th day of March 2025, and was adopted by a vote of: 4 for; 0 against; 1 abstaining; with the Chairman not voting. A quorum of 5 was present.
